## REQUEST FOR HMA PAVING BIDS No. 4

Sealed bids will be received until 1:00 PM, Wednesday, March 15, 2023, at which time they will be publicly opened and read. Bids shall be received at the office of the Antrim County Road Commission, PO Box 308, 319 E. Lincoln St, Mancelona, Michigan 49659-0308. Bids will be tabulated and a recommendation will be made to the Board of County Road Commissioners at their next regular meeting.

The Antrim County Road Commission (ACRC) requests bids for the following:

**Central Lake Garage Driveway Paving:** Project description: finish grade all gravel driveway areas paid for as Aggregate Base, Conditioning (est. 3587 Syd), pave on gravel base using 4EL in two courses each @ 165 lbs/syd (est. 592 tons) and overlay in front of salt shed on existing pavement @ 165 lbs/syd (est. 47 tons) paid for as HMA, 4EL.

Gravel will be rough graded and compacted in the designated areas by ACRC prior to paving. Contractor may use yard for transport truck transferring. See attached site plan for layout and dimensions.

All mix shall contain PG 58 -28 liquid asphalt and shall comply with the enclosed Antrim County Road Commission Special Provision for Acceptance of HMA Mixture on Non-Federal Aid Projects 01/16/23. All pay items shall be in accordance with 2020 MDOT Standard Specifications for Construction and as modified herein.

Bids must be submitted on the attached Itemized Bid Sheet.

All work shall be completed by June 30, 2023 unless otherwise agreed to by the contractor and road commission.

The successful bidder shall enter into a contract with and provided by the road commission.

Label bid "**GARAGE PAVING BID**" plainly on the outside of a sealed envelope.

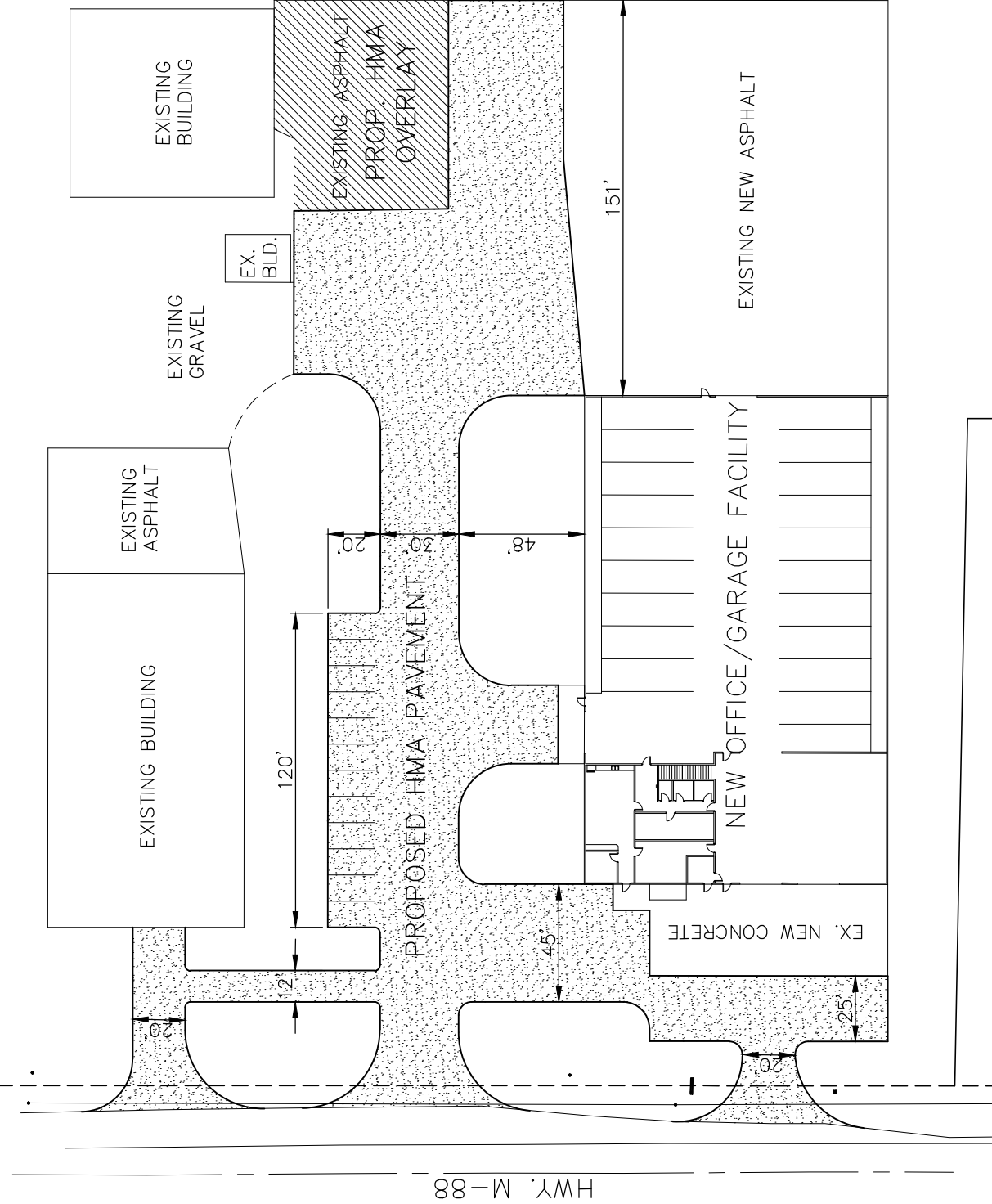
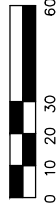
