Engineer-Manager Thompson advised that one bid was delivered at 1:45 p.m. when bids were due at 1:00 p.m. Bid was left unopened until given permission by the board to open. Bid was opened and read. Recommendation by Engineer-Manager Thompson was to award the bid Herc Rentals.

Motion by Hoogerhyde, to complete Eddy School Road all the way to M-66. Second by Giar. It was then requested to go to roll call vote. Amos - No, Giar - Yes, Hoogerhyde - Yes Motion carried by majority yes vote.

Motion by Giar, to approve 2022 ACT 51 Certification. Second by Amos. Motion carried by unanimous yes vote.

Items for Future consideration were discussed. Engineer-Manager Thompson informed the board about proposed regulations and permit requirements by EGLE for mineral well brine. A meeting with the townships to inform them of this as well as a press release after the meeting was recommended.

Bills in the amount. of \$286,616.57 covered by master voucher(s) #03, 04, 05, 05A & #06 and payroll(s) #03, & #04 in the amount of \$292,227.20 were reviewed.
